- Successfully argued *Rafal Stachowicz v. Steven W. Moore Building Corp., Ltd., et al.*, 23CA0010-M (Dec. 21, 2023) in the 9th District Court Appeals, upholding the trial court's dismissal of Plaintiffs' Consumer Sales Practices Act ("CSPA") and Home Solicitation Sales Act ("HSSA") claims against Defendant because the CSPA and HSSA do not apply to new home construction. New home construction is governed by the Home Construction Service and Supplies Act ("HCSSA").
- Following a comprehensive weeklong bench trial, the court adjudged the final will and testament of our client's mother to be legally valid, designating our client as the exclusive beneficiary of the maternal estate.
- Successfully secured a favorable jury verdict following a week-long trial in favor of Critchfield's client, the singular beneficiary of her father's trust. The verdict affirmed the trust's validity, concluding that it was established without undue influence or testamentary incapacity.
